- □ Honorees will be selected by a selected panel of judges which include community stakeholders and CBCC Board of Directors.
- □ CBCC reserves the right to eliminate any award category if no nominations are submitted for that category.
- □ CBCC reserves the right to eliminate any nomination that is incomplete, has insufficient documentation or does not fit the approved award criteria

All Nominations forms should contain detailed information with specific examples and any relevant documentation to support nomination to be reviewed for each category as requested. Final selections will be based solely on the information submitted by June 13, 2025 @ 11:59pm.

3. Provide the dollar figure or percent of revenue spent in the African American Colorado community in the past 3 years – business engagement/outreach activities preferred but can include general community engagement activities.

4. Describe formal written board and executive policy on diverse minority business development, engagement or community social responsibility.

5. Provide information on the number or percentage of diverse minority staff, board members and volunteers within your company.



6. Provide information on the staff and/or office department assigned to the task of purchasing from diverse minority-owned businesses or that engage and interact on a continuous basis with diverse minority business development organizations. Provide the name(s), title(s) and list other responsibilities of the office and include the percentage amount of time devoted by staff to the diverse minority business effort.

7. List organizations to which the company belongs that may impact diverse minority business development.

8. List three (3) vendors that can testify to the benefits they have received from the nominee's purchasing or sponsorship history from/with minority firms in the last 3 years.
